If you don't get the email, please contact Clyde promptly or time will lapse.
Cancellations 6 months or more in advance: The refund is the amount paid minus one hundred dollars (\$100.00) non-refundable administration fee.
Cancellations 3 months to 6 months in advance: The refund is 50% of the amount paid minus one hundred dollars (\$100.00) non-refundable administration fee.
Cancellations 3 months to 1 month in advance: The refund is 25% of the amount paid minus one hundred dollars (\$100.00) non-refundable administration fee.
Cancellations 1 month or less: Non-refundable.

I acknowledge that I have read the Journey Expo booth rental contract and agree to abide by the terms and conditions of this contract. I agree as the contact person, to be responsible for payments and for informing all helpers and other vendors in the booth the terms and conditions. I agree to ask the Journey approval before inviting any other vendors to share the booth.
